## **PRESIDENT'S LETTER**

If there is anything the ACBL is good at, it's finding more ways to award masterpoints. Many special games such as the Instant Gold Point game held earlier this month include an expert narrative on each of the hands for that game. There are far too many different games for a short message so I'll cover just three of them today. Your club managers work hard to find ways to get you as many points as



possible. If you have any questions about these or any other special games, they will be happy to explain them to you.

## "Gold Dust"

Each October is Club Appreciation Month, when the ACBL allows each club to run Club Appreciation Games. In a pairs game, it pays roughly triple the number of masterpoints as a regular club game. In a team game, it pays extra points <u>and</u> 5% of the total award is gold. Hence the sprinkling is called "gold dust." (The maximum gold is .25; the ACBL does after all need to have some standards!) It would have been better to let you know earlier in the month, but you still have a few days left.

## **Grand National Teams**

GNT is first cousin to the North American Pair competition discussed in the July Newsletter. For a full description see the article by George Powell elsewhere in this Newsletter.

# Sectional Tournaments at Clubs

The ACBL masterpoint formula generally dictates that clubs award black points, sectional tournaments grant silver points, and red and gold points are earned at regional and national events. There are a few exceptions, such as the Instant Match Point game held each fall and the "gold dust" games noted above. But by far the most significant hybrid is Sectional Tournaments at Clubs (ST@Cs). You play at your favorite club but the points are all silver. Your club play is a "section," as is every other participating club in the district. That means lots of sections and, just as in a regular sectional, you can score big points by doing well in the overalls. Look at what Atlantans racked up in last month's ST@C:



## SPORTSPERSON OF THE YEAR

Each year Unit 114 selects one player as its Sportsperson of the Year. This award recognizes the outstanding qualities of goodwill that make the game enjoyable for partners and opponents alike. The Unit believes so much in the importance of goodwill that it gives the player free plays in its sectionals for a year. Second place gets free plays for one sectional of his/her choice. Here is the yardstick against which candidates are measured:

- Observes both the laws and ethics of the game
- Plays competitively and is always fair
- Is gracious in victory as well as in defeat
- Is pleasant as a partner or opponent
- Exhibits good manners at the bridge table and an awareness that pleasure is also a purpose for playing bridge
- Graciously abides by the ruling of the directors and does not give unsolicited bridge lessons during the game
- Avoids discussion of boards in the presence of new opponents
- Refrains from intemperate drinking and has regards about personal appearance
- Does not become angered or quarrelsome
- Has a genuine interest in the preservation and development of duplicate bridge and the maintenance of its good reputation.



This September in a very close vote, Mike Sheldon edged out Ina Parry for this year's award. As stated on the Unit's web site, Mike "is widely admired by his partners and his opponents as being ethical, kind, patient, courteous and very generous with his bridge knowledge. Less experienced players have expressed appreciation for the time he is willing to spend helping them improve their game by answering questions and especially for cheerfully and selflessly agreeing to play with them."

And here is what the nominator had to say about Ina Parry. "Over the past five years, few have done more to grow bridge in Unit 114 than Ina Parry.... [She] is a wonderful ambassador for our game. Her gregarious nature is contagious, whether she is directing or playing. It is only fitting that Unit 114 recognize the exceptional contribution Ina Parry has made to bridge in our area."

## DBAA Opponent of the Month: Who's Bidding Against You?

With the Winter Olympics only a few months away, many people look forward to some of their favorite sporting events. Among these is figure skating, bringing together grace and athleticism in breathtaking combinations. As we watch these events, we don't think about the panel of judges with the unenviable job of picking the best of the best. If you wonder what is going on in the judge's box ask Susan Johnson, this month's DBAA Opponent of the Month. Having spent most of her life as a figure skating judge, she can tell you all about it. You will often find her playing at the Atlanta Duplicate Bridge Center with her favorite partners, husband Ron, and friend Jean Eidson. Like rising in the ranks of the duplicate bridge world, becoming a World Judge took love of the sport, dedication, years of experience, focus and the ability to keep multiple things in mind at the same time. Susan has these traits in spades!

Susan's love of figure skating began in Minneapolis, where she grew up, and where she took her first skating lessons at the age of 12. At 18, the youngest possible age, she accepted an appointment as a Test Judge, trading in her spot on the ice at competitions for a place on the judge's panel. Over many years, she worked her way through the intricacies of judging competitive figure skating to achieve the highest rank of World Judge. As a Test Judge she mastered four levels of judging competency before becoming a Competition Judge, then a National Judge, and finally achieving the rank of International Judge. To achieve the ultimate rank, World Judge, Susan passed both written and trial judging segments at the World Exam competition in Oberstdorf, Germany in 1993. Each tier of expertise required ever increasing knowledge of the many levels of difficulty in figure skating's jumps, spins and figures.

Susan accomplished the daunting goal of becoming a World Judge while still maintaining her regular life. Being a figure skating judge is not a paid career; it is essentially volunteer work. The judge's out-of- pocket expenses are paid, but the time spent at competitions — one week for a National Championship and three weeks for an Olympic event — is not compensated. So, while staying involved in the sport she loved, including skating herself for fun, Susan stayed busy building a "real" life.

After graduating from the University of Minnesota, Susan earned a Ph.D in chemistry from Northwestern University, one of only four women in her class.


They came to Atlanta when Ron was hired by Emory University as a chemistry professor. Susan soon joined the faculty of Georgia Tech, one of the first women to be hired as an instructor and researcher in the Chemistry Department. After her two daughters were born, she was a stay-at-home mom, re-entering the work place in 1989 as the Editorial Assistant for the chemical

BIDDING COMMENTARY: Routine Stayman Auction

LEAD COMMENTARY: Stands out like a sore thumb

DEFENSE COMMENTARY: Partner's lead is an obvious singleton (given the bidding, what else could it be?) and you have the ace of partner's suit plus an outside ace! Happiness. Since your outside ace in in diamonds, the HIGHER ranking of the two remaining suites, win the  $\bigstar$  A and return the  $\bigstar$  J, an abnormally high card, requesting a return in the HIGHER ranking side suit.

## THE BOTTOM LINE

1. When giving partner a ruff, your return is a suit preference play for either the higher or the lower ranking of the two side suits.

2. When giving partner a ruff with no clearcut preference for either side suit, ask partner to return the sit that is least likely to cost a trick.

# **BRIDGE AT GEORGIA TECH**

Georgia Tech has had a bridge game and/or club for

many years with varying degrees of success. At one time, you could find a pickup game in many dorms and fraternities. This is how I learned to play bridge. As is typical of many college campuses, the interest in bridge has waned for various reasons.



Tech currently has a bridge club. I and others have worked with the club for about four years--teaching formally and informally. I have helped get supplies and additional funds donated to the club. The club now has a faculty advisor, Giorgio Casinovi. Each year the club attracts up to twenty new members, but the number dwindles to fewer than ten permanent bridge players each year.

Part of the reason that the Tech Bridge Club does not grow is that students have a large number of social options. A wide variety of clubs as well as computer games attract the interest of potential bridge players.

The club members, faculty advisor and I all agree that a more aggressive effort---advertising and special events---is needed.

This year Patty Tucker taught "Learn Bridge in a Day?" and the attendance was good. She also teaches bridge each Thursday night at the Tech Student Center. There are at least three students at Tech who have participated in the Atlanta Junior Bridge program. (Another is also at Georgia State.) Now seems to be the time to help the club and support the efforts that Patty has made.

It is generally agreed that current ACBL members need actively to assist teaching bridge to younger players. While our initial focus has been on Georgia Tech, efforts at all Atlanta area colleges would be worthwhile. The Atlanta Junior Bridge program has

## **GRAND NATIONAL TEAMS**

The ACBL has kicked off the Grand National Teams Event for 2013-14, culminating at the Summer Nationals next year. The initial rounds are held at your local clubs from September through April, with the dates chosen by each Club Manager. Teams who perform well at the Club level earn qualification for the District 7 Finals. Open and Flight B Finals will be held in Morganton, NC, May 3-4, 2014. Flight A and Flight C Finals will be held in Greenville, SC, May 17-18, 2014.

Qualification for the District 7 Finals is given to all members of the team, but the qualification is as an individual to allow for teams to change members or build new teams for the District Finals. Participation at your local club does not commit you to play at the District Finals. This flexibility is necessary because the event runs over many months and in multiple locations. District 7 offers each team that wins at the District level a stipend to attend the Summer Nationals in Las Vegas next July.

There are many significant changes from prior years. (You can see them all – including much lower entry fees – at <u>http://www.district7bridge.org</u>.) There are still four flights for this event but the masterpoint levels now are: Open [No Masterpoint Limits], Flight A [0-6000 MPs], Flight B [0-2500 MPs], and Flight C [NLM up to 500 MPs]. All members of a Team wishing to compete in a particular flight must have fewer MPs than the upper limit for that flight. Eligibility for a given flight is determined at the beginning of the event; in this case your masterpoint total as of Aug. 6, 2013. This is the masterpoint total shown on your *Bridge Bulletin*, either the closing total on October's.

So join in the fun. Find your teammates for the opening rounds at your favorite clubs and bid 'em up!

journal *Orgonometallics*, published by the American Chemical Society. Amazingly, throughout these busy years she found time to travel to skating competitions, often taking her daughters along.

Susan judged her first international competition in Prague, Czechoslovakia in 1984. She has participated in judging such notables as Dorothy Hamill, Brian Boitano and Scott Hamilton. At the Nagano Olympics in 1998 she was among the judges who awarded the Gold Medal to Tara Lipinski and the Silver Medal to Michelle Kwan. As exciting as it sounds to be in the thick of such a high profile event, Susan says being a judge at the Olympics was the most nerve-wracking assignment of her career. She spent three pressurefilled weeks judging the highly talented field of skaters. Her favorite international experience was at the Goodwill Games held in Brisbane, Australia in September, 2001. She enjoyed visiting the Great Barrier Reef. Her fondest memory is of holding a koala bear! Susan finished her career as a World Judge at the 2007 World Championships held in Japan, but continues to volunteer her time as a National Judge at competitions here in the U.S. Over the course of her career, she has traveled to all fifty states, and more than thirty countries. A favorite part of her work has been seeing these places and getting to know people from all over the world.

Throughout the years, Susan has seen many changes in the sport of figure skating. The sport evolved from a technical skill-based sport to a fast paced, highly choreographed, athletic endeavor. The skating of figures, once a required element comprising sixty percent of a skater's score, was abandoned fifteen years ago.
