
President's Letter

Here's a couple of bridge tips. Neither involves bidding, play or defense. Both might help you get more enjoyment from the game.

Let me preface this first suggestion: I hate to exercise. NBA Hall of Famer Bill Russell once said, "I love exercise. I could watch it all day." I – and many of you – couldn't agree more. But if your doctor hasn't told you yet, she'll be warning that you need to walk several times a week. Unfortunately, that sounds like exercise. But here is the solution that's worked for me. Grab a bunch of bridge friends and walk together. Get a large enough group so that when one or two can't make it, you are still out there. It actually makes exercise enjoyable. And I've learned a thing or two as well.



Suggestion two requires some history. When I started playing duplicate, I kept dropping hints with my neighbor that we ought to play some time. She with 1000+ points, me with maybe 25. She finally broke down (persistence pays!) and offered this rule the first time we played. "Whenever I play with a new partner, we agree before we start that we will play a second time." Wow! That took off all the pressure, and we did well. I've now dubbed that "Maureen Rule" and try to invoke it each time I play with a new partner. By the way, Maureen and I now have earned over 1000 master points playing together. I heartily recommend the "Maureen Rule" to you. And this being mentoring month in the DBAA, what a great time to start.

Open Season for Hall of Fame Recommendations

The Hall of Fame (“HOF”) Committee has begun soliciting recommendations for membership in the DBAA Hall of Fame. **The period for submission of recommendations to the HOF Committee ends on June 30.** If you want to recommend someone for consideration, please submit a summary of your reasons to HOF Committee Chairman Mike Sheldon at mikesheldon@bellsouth.net, or to one of the HOF Committee members (Mike Sheldon, Sara Medlin, Jim Stogner) in person. Any approved inductions will be announced at the Atlanta Labor Day Regional or similar venue later this year.

The award of HOF induction is primarily intended to be recognition of achievements by the candidate in playing in ACBL sanctioned bridge events. This recognition should include accomplishments in Sectional, Regional, National, and International events. Accomplishments in club and online play may also be considered, including Sectional Tournaments at Clubs results (“STAC”), ACBL Instant Matchpoint results, McKenney and Mini-McKenney award recognition, and Ace of Clubs recognition. These achievements are intended as examples, and are by no means exclusive. Activities in and relating to the DBAA should be given particular emphasis. Significant achievement playing in ACBL bridge events shall be considered integral to this award. On the other hand, induction into the HOF is NOT to be considered a “lifetime achievement” award, and may occur at any time during or after a player’s career.

Award consideration should also include recognition of a level of service or contribution to the game of bridge within the DBAA. Other awards, such as the ACBL and Unit Goodwill Committee selection have been developed to recognize outstanding service to the game of bridge, so this factor, although given considerable importance, shall be considered a criteria secondary to bridge accomplishment for purposes of this award.

The candidate’s ethics and conduct (including both sportsmanship and general behavior) should also be given some weight in choosing a candidate.

What are your obligations? Did your brain remind you of your partner's pause?

The usual answer is, "I was always going to bid." (Why didn't you?).

"I didn't want to push them to game." (You just did).

What hand could or should you have to continue?

According to The Laws of Duplicate Bridge, Law 16, you may not choose from among logical alternative actions one that may have been suggested over another.

What does this mean when you think you have choices your partner may have taken away from you?

We polled several players on what they might do. Most said pass was a logical alternative. So you must pass. If you were going to bid to the four level, do it before partner ties your hands.

Remember, all players are allowed to take the time to think when they have a problem but their partner must not take any inference. In this hand, you have already bid the full extent of the cards you were dealt.

While we're on the subject of ethical behavior, this story from Eddie Kantar is worth repeating:

Alvin Roth, a very ethical player, is defending 7NT vulnerable in a money rubber bridge game where the declarer reduces to a three card ending. Dummy has the ♠ Axx and declarer the ♠ KJ10. The lead is in declarer's hand and he leads the ♠ J. Second hand has ♠ xxx and Roth the ♠ Qxx. Second hand goes into an act trying to make declarer think he has the queen and finally plays low. Declarer, taken in by the hesitation, also plays low. Roth, holding the queen, also plays low allowing the jack to take the trick and the declarer to make 7NT. When Roth's partner asks him why he didn't take the ♠ Q, Roth says: "Because I thought you had it!"

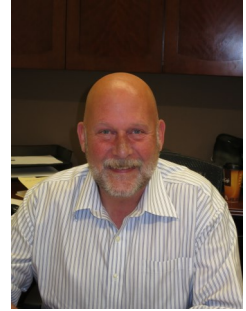

Rules

Without a doubt the Atlanta area is blessed with many very fine Directors for club games and tournaments. Every day they are challenged to make great rulings, solve interpersonal problems, deliver culinary delights, listen empathetically about the crazy drivers who made the players late to the game... Besides an occasional “thank you, you run a great game” you can help maintain the sanity of your favorite directors with a few simple suggestions.



- Wait your turn. “I called the director! I get to speak first!” Does it *really* matter? Is that the battle you really want to fight? A good director will listen for the facts. If there are additional facts needed the Director will dig for them. If your partner or opponent has forgotten a piece of information, politely let the director know you’d like to add something to the conversation. Four people talking at once solves nothing.
- Ask for clarification. If the rectifications offered don’t make sense then ask the director to repeat your options. You’re entitled to know the full impact of a selection even if, and maybe especially when, that impact is on the opponents. Law 8C1 explains:

C. Choice after Irregularity

1. When these Laws provide an option after an irregularity, the Director shall explain all the options available.

- Do NOT take any action until the director arrives. When an irregularity occurs call the director. Don’t turn over cards that have been played, don’t change your insufficient bid, don’t make comments or share your thinking process. Remember the sage advice to criminals, “Anything you say can and will be used against you...” Your thinking process, when stated aloud, becomes Unauthorized Information and may well work against you and your partner in the final ruling. Be silent, be patient, and call the director.

- Do. Not. Make. Your. Own. Rulings. Period. Want to make a grown director cry? Tell him all about how you had this ruling yesterday and you were sure you knew that this situation was the same and you didn't want to bother him and it was only a lead out of turn and... At this point the director is finally called to the table because four players are yelling at each other, fourteen previously played cards are exposed face-up on the table, someone is yelling about East having three penalty cards, West having two penalty cards, declarer having made a false claim, and how dare dummy call the director! Most directors I know would rather clean up four cups of spilled coffee than try to clean up a ruling made by the players. There are a couple of Laws we hate to but have to apply. Law 9C, for instance:

C. Premature Correction of an Irregularity

Any premature correction of an irregularity by the offender may subject him to a further rectification (see the lead restrictions in Law 26).

Or Law 10B:

B. Cancellation of Enforcement or Waiver of Rectification

The Director may allow or cancel any enforcement or waiver of a rectification made by the players without his instructions.

When an opponent is trying to make the ruling at your table remind yourself, does this opponent really have your best interests at heart? Trust me, you have a much better shot of getting the protection you deserve from an unbiased Director whose job it is to protect the rights of all players at the table.

Years ago there was a pretty good local player who I overheard telling his inexperienced opponents "your partner hesitated. You're barred from the auction." This behavior happened more than once. After a couple of warnings to this player I finally had to penalize him for saying this. Not only was he making his own ruling, he was blatantly making the wrong ruling. Who knows how many times he got away with it because those opponents chose to believe him rather than call the director.

- And finally, Directors make mistakes. They may have misheard the facts. They might have forgotten to ask a critical question. They may have gone down the wrong path and selected the wrong law to apply. It happens. Just ask yourself, how do you like to have your mistakes pointed out to you? Yelling and arguing, name-calling and threats have absolutely no place in a bridge club or at a tournament. A non-threatening "are you sure?" or "can you show me in the book?" or "can we talk about this at the break?" will invariably bring about the cooperation of the Director in solving the problem. Every director wants to get it right. Really and truly. We don't rule "for" or "against" people – we simply apply the Law.
